

**YMCA of Greater Dayton**  
**Camp Kern Activities Acknowledgment, Liability Waiver and Release Agreement**

This Camp Kern Activities Acknowledgment, Liability Waiver and Release Agreement (“Agreement”) is between the YMCA of Greater Dayton, an Ohio not-for-profit corporation (“YMCA”) and its affiliated branches, and the Camp Kern Volunteer (“Volunteer”), for itself and its heirs, assignees, and next of kin. Volunteer acknowledges there are risks in any adventure, sport, or program involving physical exertion and risk taking, or programs associated with the outdoors that are inherent in the activity. Volunteer understands and agrees that by participating in the Camp Kern program of activities including but not limited to those identified in Exhibit A. Volunteer will be involved in activities including, but not limited to, problem-solving, team-building initiatives, ropes course, and other activities that will require physical exertion.

Volunteer acknowledges and agrees that the risks set out above, as well as other natural hazards do exist, that although the activities may be strenuous, injuries or medical complications may occur, certain foreseeable and unforeseeable events unique to each individual activity can contribute to the unpredictability of the activity, that balance and physical coordination can affect the occurrence or severity of accidents or falls, and that if Volunteer has questions about specific risks or hazards, Volunteer will communicate those questions to a YMCA employee before participating in any activity.

**ASSUMPTION OF RISK:** In recognition of the inherent risks of the activity which Volunteer, and any minor children for which Volunteer is responsible, will engage in, Volunteer confirms that he or she is (and said minor children are) physically and mentally capable of participation in the activity and using required equipment. Volunteer hereby assumes complete responsibility for risk of bodily injury, death, or property damage arising from Volunteer’s presence and participation in any activities at Camp Kern, including but not limited to use of facilities or equipment, regardless of whether such harm is due to the sole or partial negligence of YMCA, its directors, officers, employees, agents or volunteers (“Released Parties”). Specific risks Volunteer assumes include, but are not limited to, personal injury, accidents or illnesses, diseases, sprains, torn muscles, and/or ligaments, fractured or broken bones, eye damage, cuts, scrapes, abrasions, contusions, dehydration, oxygen shortage, exposure or altitude sickness, head, neck or spinal cord injuries, animal attack or insect bite, injury caused by the discharge of a weapon, shock, paralysis or death. Volunteer acknowledges and accepts that if he/she experiences fatigue, dizziness, chill or other similar condition, it may diminish reaction time and increase the risk of an accident.

Volunteer recognizes that the YMCA will operate at all times in good faith and fair dealing, but that it may become necessary to terminate any activity due to acts of God, medical necessity, or other problems, and may also refuse or terminate the participation of any person incapable of meeting the requirements of participation in a particular activity. Volunteer accepts the YMCA’s ability to do this and agrees that no guarantees or promises have been made that are not part of this Agreement to the contrary. Volunteer agrees he or she has a duty to disclose known or emerging conditions that may affect Volunteer’s ability to engage in activity.

Volunteer hereby authorizes any medical treatment deemed necessary in the event of injury while participating in the Program. Volunteer has appropriate insurance or if not insured, Volunteer agrees to pay all costs of rescue and any medical services that may be rendered or incurred on Volunteer’s behalf. Volunteer also authorizes the use of photographs, video and audio recordings of Volunteer’s activities at Camp Kern to be used in marketing, educational, or other purposes.

**RELEASE:** In consideration of services or property provided, Volunteer, for myself and any minor children for which Volunteer is a parent, legal guardian, or otherwise responsible, any heirs, personal representatives or assigns does hereby release the Released Parties for any loss or damage, and any related claims or demands for injury to person or property, including death of any person, whether or not caused by negligence of the Released Parties and waives any claims Volunteer may have against Released Parties.

Volunteer agrees to indemnify, defend, and hold harmless each of the Released Parties from any loss, liability, damage or cost Volunteer may incur arising from participation in Camp Kern, including but not limited to use of YMCA equipment, regardless of whether such harm is caused by the sole or partial negligence or fault of Released Parties.
